

## **Authorized Inspector Opportunity**



### Become an Al

- Start a new career,
- or Enhance your existing Environmental business.
- Increase your cashflow.

- The iEHO AI opportunity is useful and profitable for Environmental Engineering and Inspection Firms, Building and Home Inspection Firms and Individuals, Inspectors of all types, and Individuals who wish to start a new business and career in the Environmental field.
- As an iEHO Authorized Inspector, you will be "authorized" to provide iEHO Certifications.

#### Al Requirements and Qualifications:

- When applying for AI registration, Individuals or Firms must provide proof of adequate certification with documentation from a bona fide school, college, university, or training organization.
- An applicant must have an Environmental related degree, or have educational or training certification in an Environmental Inspection or Assessment related discipline. Note: There are numerous organizations and institutions that offer short and longer courses, certifications and and educational programs related to environmental inspection and assessment. For example: ACAC. iEHO supports and considers all related organizations, institutions, courses, and certifications.
- An "Authorized Inspector" designation will be granted on the merits of an applicant at the discretion of iEHO.
- Once an applicant is "approved", the iEHO "Authorized Inspector" designation will be granted upon receipt of the "one time" initial licensing fee. Access will then be provided to "AI" resources.
- Non-refundable fees (usd): \$105.00 application fee due with application, plus \$945.00 "one time" initial licensing fee due upon approval.
- Initial licensing fee includes 2 year waiver of annual Al licencing fee (value = \$75.00 per year).
- The annual Al licencing fee may also be waived based on Certification volumes after 2 years.








## **iEHO Authorized Inspector Agreement**



Upon becoming "authorized" for the provision of iEHO certification programs, an iEHO Authorized Inspector (hereafter referred to as AI) is subject to the following agreement and terms:



1) In the provision of iEHO certifications, an AI is entitled to use and display all of iEHO intellectual property in the context of the provision of certification programs. This includes the use of all iEHO Trademarks, Certification marks, Service marks, Copyrighted materials.

It is incumbent upon an AI to protect iEHO against any known disparaging use of this property.

#### Use of iEHO Standards and Protocols:

**2)** For the determination and provision of iEHO certifications by an AI, the use of iEHO Standards and Protocols, as specified in the iEHO IAQ Standards, Guidelines, and Testing Protocols documents, is mandatory.

#### iEHO Standards of Ethics and Quality:

- **3)** In addition to being bound by any other "code of ethics" or "quality control standards" that an AI may be subject to by any other related certifications or memberships, an AI must agree to and abide by the following:
- **a)** to remain neutral to any third party interests by providing accurate and honest testing and results;
- **b)** to maintain and keep confidential, all client information and respective test results, determinations, and conclusions. Accordingly, an AI shall not provide any information to any third party outside of iEHO, without consent of the client, and/or iEHO.
- **c)** an AI must also maintain what is generally considered "good and fair" business practices in all dealings with clients.

#### Indemnification:

**4)** In the provision of iEHO certifications, an AI shall fully indemnify iEHO against any misuse or misrepresentation by their own action, deliberate or otherwise, in the provision of any iEHO service or program.

#### **Cancellation and Termination:**

- **5)** At the discretion of iEHO, any of the following is grounds for termination of this agreement:
- a) disparagement or misuse of the iEHO name or intellectual property;
- b) any material breach of this agreement;
- c) deceiving or fraudulent business practices;
- d) nonpayment of any iEHO required fees. At the discretion of iEHO, any required fees that are 60 days past due, are considered "not paid".
- **6)** An AI may cancel this agreement at any time. Upon cancellation, an AI will immediately become "unauthorized" to provide iEHO certifications. A former AI may reactivate this agreement at any time by requalifying, and paying any prescribed fees at the discretion of iEHO.

### Fees, Payments, Reactivation:

- **7)** All prescribed fees as noted in the prior "Authorized Inspector Opportunity" section, must be paid before "authorization" is granted.
- **8)** Any fees may be paid by check, money order, bank draft, or by the preferred method being "Interac email funds transfer" (eft). All fees are in US dollars. All fees paid by check are not considered "paid" until the check clears.
- **9)** Reactivations of this agreement may be subject to requalifying, and payment of additional fees.
